Face mask - 2 layers

Reusable textile face mask from 100% BIO cotton with GOTS certificate.

The product is made in the Czech Republic.

# Material:

- (i) Bleached fabric 100 % organic cotton PERCALE GOTS 120 g/m<sup>2</sup>;
- (ii) Woven and knitted fabrics as well as tapes made of 100 % polyester resp. 100 % polyamide (polyester-satin, knitted satin, velvet, rip cord, polyamide velour, blocked mesh, micro fibre, taffeta, spacer fabric), woven fabrics made of 100 % cotton and cotton in blends with polyester, cotton-molton, twilled cotton, white, dyed, pigment printed, goldglitter printed, cords made of cotton, polyester and acrylic in different colours, nonwovens made of polypropylene, woven fabrics made of polyester/metallized yarn/polyamide in gold and silver; and reflecting tape 3M article 8912 and 8925; woven fabrics made of cotton are partly finished with flame retardant products, accepted by OEKO-TEX, produced by using material certified according to STANDARD 100 by OEKO-TEX; and
- (iii) Sewing thread made of PES: Saba Wre, Sabatex, Sabasoft, Sabaflex, Serafil, Serafil Wre, Isacord, Isacord Multicolour, Isa, Isa Textlight, Universal, Crown, Belfill-S, Texam, Synton, Terrier, Pescon-T, white and dyed (including neon colours); Texturan, white and grey; Topfil, white; made of PA: Garment Dyeing Bauschgarn PA-SGD, undyed; Onyx, white; made of recycled PES: Saba Recycled, Sabatex Recycled, Universal Recycled, white and dyed; made of PES: Cordonnet, Extra Stark, Seracor, Metrosene, Seralon, Troja, Trojalock, Bobbinette, Seraflock, Aspotex, Aspo, Seraflex, Seralene, Poly Sheen, Poly Sheen Multi, white and dyed (including neon colours); made of PP/PBT: Poly Glow, with glow in the dark effect, champagne (1260); produced by using materials certified according to STANDARD 100 by OEKO-TEX.

#### Product storage and care

Protect from UV radiation and moisture, store away from heat source in a dry, well-ventilated area. The product can be boiled to 95 degrees (up to 150 wash cycles), is intended for repeated use and is not intended for sterile environments such as operating theatres.
